

**NOTICE**  
**WESTMORELAND COUNTY**  
**SOLID WASTE DISPOSAL PROCEDURES**

Residents of Westmoreland County, Virginia are required to display the Westmoreland County Waste Disposal Permit in their vehicle when disposing of waste at any of the County's three solid waste disposal sites. Persons not displaying the Westmoreland County Waste Disposal Permit will not be allowed to dispose of their waste at any site.

There will be an **annual reissue** of your Westmoreland County **WASTE DISPOSAL PERMIT**. The permit validity dates are visible on your disposal tag below the permit number. Each year the permits will display a different color.

Permits are available to residents at the Westmoreland County Treasurer's Office, located at the rear entrance of the George D. English, Sr. Memorial Building, 111 Polk Street, Montross, VA. Permits are issued upon verification that all personal property and real estate taxes have been paid. Those residents who are renting should present proof of residency to receive their permits or ask the owner of the property for the use of the permit associated with the rental property.



Westmoreland County's solid waste disposal convenience sites do not accept cash, check or credit card payments for the disposal of brush, tires, or electronics. Payment for the disposal of such items must be in the form of a Westmoreland County coupon. Coupons are available for purchase at the Westmoreland County Treasurer's Office during normal business hours: Monday – Friday, 8:30 a.m. to 4:30 p.m. (except during holidays and inclement weather). Coupons are non-refundable/non-transferable and will expire on June 30<sup>th</sup> of each fiscal year. ## BRUSH DISPOSAL FEES

The rates for brush disposal are as follows:

\$ 5.00	Truck
\$ 5.00	8 ft. Trailer
\$10.00	Truck and Trailer
\$10.00	Trailer over 8 ft.
Per Ton	Large trucks are weighed and charged by the ton.

Single coupon: \$5.00

Book of four coupons: \$20.00

\*Brush is accepted for disposal at the Montross convenience site only.

## TIRE DISPOSAL FEES

The rates for tire disposal are as follows:

\$1.00 per tire (off wheel) per passenger tire  
\$2.00 per tire (on wheel) per passenger tire

\$1.00 per tire (off wheel) per light truck tire (16-17")  
\$2.00 per tire (on wheel) per light truck tire (16-17")

\$5.00 per tire (off wheel) per large truck (tractor/truck)  
\$8.00 per tire (on wheel) per large truck (tractor/truck)

\$20 + per tire (off wheel) large off-road and equipment tires (depending on size)

\*Tires are accepted for disposal at the Montross convenience site only.

Single coupon: \$1.00

Book of ten coupons: \$10.00

OR

Single coupon: \$5.00

Book of four coupons: \$20.00

## ELECTRONICS DISPOSAL FEES

The rates for electronics disposal are as follows:

\$5.00 (up to five items per visit)

Single coupon: \$5.00

Book of four coupons: \$20.00

\*Electronics are accepted for disposal at either of the County's three convenience sites:  
Montross, Carmel Church, or Monroe Hall.
